## **Privacy Policy:**

Tony The Window Man Limited ("Tony The Window Man") operates Tonythewindowman.co.uk and may operate other websites. It is Tony The Window Man's policy to respect your privacy regarding any information we may collect while operating our websites.

#### Website Visitors

Like most website operators, Tony The Window Man collects non-personally-identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Tony The Window Man's purpose in collecting non-personally identifying information is to better understand how Tony The Window Man'S visitors use its website. From time to time, Tony The Window Man may release non-personally-identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Tony The Window Man also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on tonythewindowman.co.uk, Tony The Window Man only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that commenter IP addresses and email addresses are visible and disclosed to the administrators of the blog/site where the comment was left.

## Gathering of Personally-Identifying Information

Certain visitors to Tony The Window Man's websites choose to interact with Tony The Window Man in ways that require Tony The Window Man to gather personally-identifying information. The amount and type of information that Tony The Window Man gathers depends on the nature of the interaction. For example, we ask visitors who sign up at tonythewindowman.co.uk to provide a username and email address. Those who engage in transactions with Tony The Window Man are asked to provide additional information, including as necessary the personal and financial information required to process those transactions. In each case, Tony The Window Man collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Tony The Window Man. Tony The Window Man does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

## **Aggregated Statistics**

Tony The Window Man may collect statistics about the behavior of visitors to its websites. Tony The Window Man may display this information publicly or provide it to others. However, Tony The Window Man does not disclose personally-identifying information other than as described below.

## Protection of Certain Personally-Identifying Information

Tony The Window Man discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organisations that (i) need to know that information in order to process it on Tony The Window Man's behalf or to provide services available at Tony the Window Mans websites, and (ii) that have agreed not to disclose it to others. Some of those employees, contractors and affiliated organisations may be located outside of your home country; by using Tony The Window Man's websites, you consent to the transfer of such information to them. Tony The Window Man will not rent or sell potentially personally-identifying and personally-identifying information to anyone. Other than to its employees, contractors and affiliated organisations, as described above, Tony The Window Man discloses potentially personally-identifying and personally-identifying information only in response to a court order or other governmental request, or when Tony The Window Man believes in good faith that disclosure is reasonably necessary to protect the property or rights of Tony The Window Man, third parties or the public at large. If you are a registered user of an Tony The Window Man website and have supplied your email address, Tony The Window Man may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Tony The Window Man and our products. If you send us a request (for example via email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Tony The Window Man takes all measures reasonably necessary to protect against the unauthorised access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

## Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Tony The Window Man uses cookies to help Tony The Window Man identify and track visitors, their usage of Tony The Window Man website, and their website access preferences.
